हैं, जिनकी कुल संपत्ति 4,90,97,914 रुपए है, जिसमें 1,80,00,000 रुपए की अचल संपत्ति शामिल है। इसमें कहा गया है कि इनके बाद भाजपा की अनुराग राय चक्रवर्ती (तलडांगरा) हैं, जिनकी कुल संपत्ति 2,98,59,287 रुपए है और तृणमूल कांग्रेस के श्यामल कुमार घोष (मेदिनीपुर) 1,69,43,060 रुपए हैं। हलफनामों के अनुसार, उम्मीदवारों की औसत संपत्ति 58.14 लाख रुपए है। विश्लेषण के अनुसार कृचबिहार सीताई (एससी) से कामतापुर पीपुल्स पार्टी (यूनाइटेड) के उम्मीदवार काशीकांत बर्मन के पास सबसे कम घोषित संपत्ति है, जो मात्र 5,000 रुपए है।

'लोगों का विभाजन रोकने के लिए जान देने को तैयार हूं'

कोलकाता, 7 नवंबर (भाषा)।

पश्चिम बंगाल की मुख्यमंत्री ममता बनर्जी ने गुरुवार को कहा कि वह धर्म और जाति के आधार पर लोगों के विभाजन को रोकने के लिए अपनी जान तक कुर्बान करने को तैयार हैं। उन्होंने कहा कि भारत में लोग चाहे किसी भी धर्म, जाति और पंथ के हों, एकसाथ रहते हैं तथा कोई भी व्यक्ति दूसरों से श्रेष्ठ नहीं है। ममता ने छठ पूजा के अवसर पर कोलकाता में कहा कि ऐसे लोग हैं जो लोगों के बीच विभाजन पैदा करना चाहते हैं। लेकिन मैं वह नहीं चाहती। मैं अपनी जान तक देने को तैयार हूँ लेकिन कोई विभाजन नहीं होने दूंगी। हर धर्म की अपनी विशेषताएं हैं। मैंने किसी धर्म के खिलाफ कभी नहीं बोला।



मुख्यमंत्री बनर्जी ने कहा कि यह भारत है जहां सभी धर्मों, जातियों और पंथ के लोग साथ रहते हैं। कोई भी श्रेष्ठ या निम्न नहीं है।

कोई भी श्रेष्ठ या निम्न नहीं है, भले ही वह ब्राह्मण, एससी (अनुसूचित जाति), एसटी (अनुसूचित जनजाति) या किसी अन्य धार्मिक समूह का क्यों न हो। हम इस एकता को खत्म नहीं होने देंगे। उन्होंने कहा कि बंगाल में, यह परंपरा आजादी के समय से है। देश के स्वाधीनता संघर्ष में सर्वाधिक योगदान देने के मामले में पंजाब के बाद बंगाल का ही स्थान है। पश्चिम बंगाल सरकार ने छठ पूजा के अवसर पर सभी कार्यालयों में दो दिन के अवकाश की घोषणा की है।

हथियारबंद बदमाश ट्रक लेकर फरार

कोलकाता, 7 नवंबर (भाषा)।

कोलकाता में पांच हथियारबंद लोगों ने बंदूक दिखा कर एक ट्रक के चालक को लूटा और फिर उसका ट्रक लेकर भाग गए। पुलिस के एक वरिष्ठ अधिकारी ने गुरुवार को यह जानकारी दी।

वरिष्ठ अधिकारी ने बताया कि यह घटना रात करीब दो बजे यहाँ मणिकटला इलाके के पास काकुरगछी मुख्य मार्ग पर हुई। अधिकारी ने बताया कि ट्रक चालक देवेन्द्र चौबे ने दावा किया कि सामान उतारने के बाद वह मणिकटला मुख्य मार्ग से स्ट्रैंड रोड की ओर जा रहा था, तभी विपरीत दिशा से तेज गति से आ रही एक कार ने उसका रास्ता रोक लिया। अधिकारी ने कहा कि चालक ने आरोप लगाया कि पांच लोग जबरन उसके ट्रक के 'केबिन' में घुसे और उसके साथ मारपीट कर उसे ट्रक से बाहर धकेल दिया। इसके बाद उन्होंने उसका मोबाइल फोन, रुपए और ट्रक की चाबियाँ छीनीं लीं और ट्रक लेकर वहाँ से भाग गए। उन्होंने बताया कि घटना के दौरान चालक उस निजी कार का पंजीकरण नंबर नोट नहीं कर सका जिसमें हथियारबंद लोग आए थे।

राष्ट्रीय महिला आयोग ने अपनी एक सदस्य अर्चना मजूमदार से जुड़ी घटना की उच्च स्तरीय जांच की मांग की है। आरोप है कि कोलकाता पुलिस के कर्मियों ने मजूमदार को कथित तौर धमकाया और घायल कर दिया। गत एक नवंबर को हुई इस घटना के चलते आयोग ने कोलकाता पुलिस और गृह मंत्रालय को एक आधिकारिक पत्र भेजा है।
